BECAUSE SOME CLIENTS ARE TOO WEAK OR ILL TO PICK UP THEIR ORDERS FROM FOOD OUTREACH OUR PART-TIME VAN DRIVER DELIVERS UP TO 60 MEALS (2 PER DAY) EVERY MONTH TO EACH HOMEBOUND CLIENT.

NUTRITION EDUCATION:

FOOD OUTREACH PROVIDES EDUCATION BREAKFASTS AND COOKING CLASSES TO HELP CLIENTS ESTABLISH GOOD NUTRITION HABITS FOR LIFE. BREAKFAST AT FOOD OUTREACH IS OPEN FOR CLIENTS, FAMILY MEMBERS, AND GUESTS TO PROVIDE A UNIQUE FORUM FOR GROUP EDUCATION AND DISCUSSION. OUR DIETICIAN DEVELOPS A COMPREHENSIVE CURRICULUM AND INVITES EXPERTS TO SPEAK ON VARIOUS NUTRITION TOPICS RELEVANT TO PEOPLE LIVING WITH SPECIFIC DISEASES. QUARTERLY COOKING CLASSES ARE HELD FOR CLIENTS TO LEARN HOW TO COOK AND PROPERLY PREPARE FOOD TO ENSURE A NUTRITIOUS AND APPETIZING MEAL. CLASSES FOCUS ON FOOD SAFETY AND THE DANGER OF FOOD BORNE ILLNESS, KNIFE SKILLS, HEALTHY COOKING, MEAL PLANNING AND READING LABLES.

WHILE IN-PERSON EDUCATION BREAKFASTS AND COOKING CLASSES WERE CANCELLED DUE TO THE COVID-19 PANDEMIC, EDUCATIONAL VIDEOS WERE UPLOADED EACH MONTH TO FOOD OUTREACH'S WEBSITE AND NUTRITIONAL EDUCATION MATERIALS WERE INCLUDED IN THE MONTHLY NUTRITION BOXES CLIENTS RECEIVED.

EACH MONDAY FOOD OUTREACH INVITES OUR CLIENTS AND THEIR GUEST TO JOIN US FOR A THREE-COURSE, RESTAURANT-STYLE MEAL SERVED HOT AND FRESH IN OUR DINING ROOM. THIS WEEKLY COMMITMENT ALLOWS CLIENTS THE OPPORTUNITY TO ENJOY A DELICIOUS MEAL AND HAVE AN RECURRING OPPORTUNITY
